Citation

Roger Crofts has made significant contributions to protected areas policy, governance, management and advocacy for over 40 years nationally, regionally and globally. As the Founder Chief Executive of Scottish Natural Heritage he achieved the successful implementation of Natura 2000 using tailormade consultation procedures and management incentives schemes, placing protected areas in their landscape context through Natural Heritage Futures. In Europe, he led the volunteer network of

WCPA for 8 years with drive and determination, resulting in a focussed programme of work and active volunteer network and much improved links to IUCN activities in the region. Around Europe, Roger advised on innovative ways to achieve improved protection of sites, especially in Iceland, including establishment of Europe's largest National Park Vatnajökull and National parks in Denmark, argued for removal of perverse incentives, especially reform of the EU Common Agricultural Policy, and produced new governance models (e.g. for Bulgarian PAs). Globally, Roger undertook an in-depth review of the WCPA and the GPAP in 1998, at the Vth World Parks Congress, Roger led the formulation of the Durban Accord and Action Plan which became the foundation for the CBD PoWPA. He persuaded colleagues to change the definition of a protected area to include abiotic nature, stimulating the formation of the Geoheritage SG, and leading on best practice guidelines for geoheritage conservation. Colleagues describe Roger as a grounded, energetic, clear thinking and encouraging environmentalist. He is a mentor and adviser of the highest calibre.
